### OIL BURNER SERVICE AGREEMENT

**This agreement is contingent on the following:**

The above customer address purchases ALL FUEL OIL from Visconti Fuel, LLC. If above customer address is NOT on automatic delivery, or if oil deliveries have been suspended due to CREDIT PROBLEMS, any damage caused to the unit by letting the unit run low on fuel is NOT COVERED. Also, if an automatic customer refuses delivery for any reason, any damage caused to the unit by letting the unit run low on fuel is NOT COVERED.

If customer has a balance due OVER THIRTY DAYS, or if customer is more than one month in arrears on budget payments, this contract is AUTOMATICALLY NULL AND VOID.

Visconti Fuel will make every effort to contact the customer to schedule the Annual Service. However, it is the customer's ultimate responsibility to schedule the Annual Service within the terms of this agreement. There will be NO CREDITS or "CARRYOVERS" for services not performed.

Heating Unit is subject to inspection by our Oil Burner Technician.

**PLAN 1**

FULL 24-HOUR COVERAGE PLAN

**\$175.00 plus tax**

This plan covers all emergency no heat service \*\*twenty-four hours a day, seven days a week, parts and labor\*\* for one year beginning the date contract is **due and paid**. This plan also covers annual oil burner tune-up, vacuum cleaning of furnace or boiler, and smoke pipe (if needed).

**PLAN A**

**\$75.00 plus tax**

This plan is designed for customers with a separate oil fired water heater. It can ONLY be purchased in **addition** to Plan 1. This plan covers all service calls, but only MONDAY THRU FRIDAY, 8:00 AM - 4:30 PM. It does not cover after hour calls, nor weekends or holidays. Service calls on these days or after normal working hours will be billed accordingly (parts and labor). This plan does cover annual oil burner tune-up\*.

- ?? Annual service must be scheduled Monday thru Friday, 8:00 AM - 2:30 PM ONLY.
- ?? A service call is considered an emergency when the heat in the main zone is off. Oil smells, noises, and no hot water calls are not considered to be an emergency, and will be dealt with during normal working hours; or these calls will be billed according to prevailing rates, parts and labor.
- ?? If part is **Not** covered by the plan, labor will be charged.
- ?? Any parts not listed above are **Not** covered by the plan.
- ?? If serviceman is dispatched for a problem that results in any switches off, customer will be charged labor.
